Dear Mr. Ambassador:

As counsel for Michael C. Cottrell, president and major shareholder of Cottrell

for the U.S. Dollar Refunding Project, et. al, I am constrained to bring these  
matters to your attention. This is in furtherance to my correspondence with you.  
I am now advised as follows:

1. On 17 JUNE 2011 between approximately 11:17 A.M. and 11:19 A.M., several world bankers stated the following:
  - a) That President Obama has had on his desk, for signature, a U.S. Tax provision, regarding the Iraqi Dinar Fund, which would require a Cash-in within the United States, that requests 11+% of the Fund.
  - b) President Obama had pledged to sign said legislation (Friday, 17 June 2011), but that President Obama refused to sign the document UNTIL HE (pers. COMMUNICATION) RECEIVES MORE MONEY; and
